The undersigned [on my own behalf and on behalf of my heirs, personal representatives, successors and assigns] for and in consideration of the opportunity to participate in a "ride, rally, field meet or activity" hereinafter, "Event" sponsored or conducted by the Siskiyou County Veterans Service Office and their respective officers, directors, employees and agents [hereinafter the "released parties"] releases and holds harmless the "released parties" from any and all claims and demands, rights and causes of actions of any kind whatsoever which I now have against the "released parties" in any way resulting from, arising out of, or in connection with the performance of their work duties and my participation in any said "events". This release extends to any and all claims I have or later may have against the "released parties" resulting in or arising out of their performance of their duties whether or not such claims result from negligence [except willful neglect] on the part of any or all of the "released parties" with respect to the "event" are conducted or from any other cause. I understand that this means that I agree not to sue any or all of the "released parties" for any injury resulting to myself, my passenger or my property, arising from or in connection with the performance of their duties in sponsoring, planning or conducting the event[s]. I am experienced in and familiar with the operation of two and/or three wheeled motorcycles and fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in the event[s] and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation

in the event[s] and any negligence [except willful neglect] on the part of any of the “released parties” in performing their duties.

WAIVER OF RIGHTS UNDER STATE STATUTES

I further agree to waive all benefits flowing from any state statute, which would negate or limit the scope of this Release and Indemnification Agreement, including but not limited to Section 1542 of the California Civil Code which provides; “A general release does not extend to the claims which the creditor does not know or suspect exists in his favor at the time of executing this release, which if known to him must materially affect his settlement with the debtor”. By signing this release I certify that I have read the release and fully understand it and that I am not relying on any statements or representations made by the “released parties”.
